To carry out these duties, the attorney will review appellate briefs, records, and other filings, and research and analyze the applicable law.

The Fifth District Court of Appeal is known as a very collegial and supportive workplace. Fresno has a reasonable cost of living, easy commute, and satisfying lifestyle. ## **MINIMUM QUALIFICATIONS (This position is open to applicants at all levels with Senior being the highest level)**

**Senior Appellate Court Attorney:** Active membership in the State Bar of California and the equivalent of six years of post-bar legal experience, including substantial appellate experience, in a legal setting such as a private law practice, corporation, government agency, law school, court, or legal publishing company **OR** two years of experience as an appellate attorney, Level D, with the judicial branch.

- *Work experience as a law clerk to a federal judge after passing a state bar but prior to formal state bar admission will be considered equivalent to post-bar legal experience.*
- *For external candidates for the Senior Appellate Court Attorney class, the Administrative Presiding Justice must certify that the candidate possesses “substantial appellate experience.”*

**Level D:** Active membership in the State Bar of California and the equivalent of four years of post-bar legal experience in a legal setting such as a private law practice, corporation, government agency, law school, court, or legal publishing company **OR** one year of experience as an appellate attorney, Level C, with the judicial branch.

**Level C:** Active membership in the State Bar of California and the equivalent of three years of post-bar legal experience in a legal setting such as a private law practice, corporation, government agency, law school, court, or legal publishing company **OR** one year of experience as an appellate attorney, Level B, with the judicial branch.

**Level B:** Active membership in the State Bar of California and the equivalent of two years of post-bar legal experience in a legal setting such as a private law practice, corporation, government agency, law school, court, or legal publishing company **OR** the equivalent of two years of post-bar legal experience in a legal setting described above, including one year of experience as an appellate attorney, Level A, with the judicial branch.
