We seek applications from current law students (with an anticipated graduation date in May 2024 or sooner), recent law graduates, and judicial clerks who share our commitment to performing the highest quality legal work to advance the public good.

Applicants must be able to commit to one year of service to be considered for the Fellowship. Applicants must be, as of the start date of the Fellowship, (1) admitted to the bar of a state, territory, or district of the United States, or (2) awaiting exam results or admission after taking a bar exam.

### Compensation and Benefits

Fellows will receive a salary of \$85,000 annually and will be eligible to participate in the Firm’s full benefits package.

school transcript, and writing sample of about 2,500 words or less. Please advise us of your bar-admission status in your cover letter.
