## HIRING ANNOUNCEMENT FOR DEPARTMENT OF ENERGY, LOAN PROGRAMS OFFICE ATTORNEY ADVISOR, 0905-GS 14/15

#### Overview

The U.S. Department of Energy's Loan programs office (LPO) provides debt financing for large-scale, innovative energy infrastructure and advance technology manufacturing projects in the United States and for the Tribal Energy Finance Program.

As an Attorney Advisor you will administer the following programs with more than \$100 billion available loans and loan guarantees in the following areas:

- Tribal Energy Financing Program: Loan Guarantees for Tribal Energy Projects- LPO supports tribal investment in energy-related projects by providing direct loans or partial loan guarantees to federally recognized tribe, including Alaska Native village or regional or village corporations; or a Tribal Energy Development Organization (TEDO) that is wholly or substantially owned by a federally recognized Indian tribe or Alaska Native Corporation.
- Title 17 Clean Energy Financing: Loan guarantees for Innovative Clean Energy Projects, Innovative Clean Energy Supply Chain Project, State Energy Financing Institution Supported Projects, and Energy Infrastructure Reinvestment Program Projects
- ATVM Loan Program: Direct Loans for Manufacturing of Advanced Technology Vehicles and Qualifying Components

The attorney in this position will have primary responsibility for providing legal support to the Tribal Energy Finance Program. The attorney will support LPO in all rulemaking, program design, tribal consultation, eligibility determinations, and other tribal law matters related to the Tribal Energy Finance Program, as well as support the office in connection with Tribal Energy Finance Program loan guarantee applications and transactions. They attorney will also support the other loan programs administered by LPO as appropriate.

This is a developmental position with promotion potential to General Attorney, GS-0905-15. At starting grade GS-14, the selectee will execute developmental assignments, and initial supervision and guidance will be greater than that required at the full performance level of GS-15. Assignment will become more challenging and performed with greater autonomy as selectee performance level progresses. At the full performance level of this position (GS-15) duties include:

- Administer Loan Programs
- Manage the drafting, negotiation, closing, and administration of loan documents for loans made and loan guarantees issued.
- Provide analyses, advice, guidance, and assistance on issues and questions of exceptional difficulty that have crucial influence on the LPO Programs.
- Provide interpretations, legal advice, determinations and opinions on a wide range of extraordinary, novel, controversial and complex and questions.

Experience in Indian law, tribal finance, and Federal secured lending programs is preferred but experience in all three is not a prerequisite. The job location is Washington, D.C. (preferred hybrid role but fully remote applicants will be considered).
